WHEREAS,	A resolution, provided by Dickinson Wright, is being considered by all of the Bay Area Water Treatment Plant (BAWTP) stakeholder communities with a goal to have all of the resolutions passed by the end of August creating an opportunity for a resolution to be adopted by the Bay County Board of Commissioners on September 14, 2021; Therefore, Be It

WHEREAS, A number of months ago a presentation and

A number of months ago a presentation and request was made by the Friends of the Pinconning Community Center for a "donation" to the 501(C)(3) group from the County to aid in the rehabilitation and reconstruction of the Pinconning Community Center (the "Community Center"). The Community Center is currently owned by the Pinconning

Downtown Development Authority ("DDA"); and

WHEREAS,
The matter was referred to administration and discussions were held between the Board Chair, Ways and Means Committee Chair and Corporation Counsel regarding the legality of the County making a charitable donation as requested and it was determined that while "donations" of public funds by the County are not lawful, the County may enter into a written agreement with another entity for services the County is allowed by law to

provide, with an expectation that the return received by the County has equal or better

value that the amount contributed; and

WHEREAS, Discussions were further held with members of the "Friends of" group as well as a representative of the Pinconning DDA and the Bay County Department on Aging, and it was communicated that there was a need for senior services in the Pinconning area for recreation and community events for seniors, as well as the possibility of the Department on Aging at some point utilizing the Community Center as a communal dining site for

seniors; and

WHEREAS,

Bay County is allowed by law to provide such services to seniors throughout Bay County, and, as a result, it was determined that the County may legally contribute a sum to the Pinconning DDA to assist in the renovation of the Community Center kitchen area to conform with the necessary requirements to utilize the site as either a communal dining site with a warming kitchen (if feasible within the constraints of food transport) or

eventually as a full service kitchen, as well as an event site for senior activities sponsored and conducted by the Department on Aging, so long as the County is allowed to utilize the space for those purposes free of charge for an agreed upon number of years to ensure that the return received by the County has value equal to the amount contributed toward

the kitchen renovation; and

WHEREAS, The contracted amount to be utilized for kitchen renovations in exchange for use of the community center space as requested is \$25,000 and this amount would be deducted

from Bay County's General Fund; Therefore, Be It

RESOLVED

That the Bay County Board of Commissioners approves an Agreement with the Pinconning Downtown Development Authority contributing \$25,000 toward the cost of renovating the Pinconning Community Center kitchen in exchange for the ability of the Bay County Department on Aging to utilize the Community Center space as a communal diving site (as

WHEREAS,

Since the creation of the Voluntary Employees' Beneficiary Association (VEBA) Trust, the VEBA Board and Bay County Employees' Retirement System (BCERS) Board have had the same trustee composition. In 2010, when BCERS changed its composition from a seven (7) to a nine (9) member board, the VEBA Board followed suit and it went from operating as a seven (7) member board to a nine (9) member board. However, while the Retirement Ordinance was updated to reflect this 2010 change, no amendment was made to the VEBA Trust; and

WHEREAS,

On July 13, 2021, the VEBA Board voted to formally request that the Bay County Board of Commissioners amend the VEBA Trust so that the VEBA and BCERS Board compositions are the same; and

WHEREAS,

Bay County and certain Component Units of Bay County provide qualified retired employees with Retiree Medical Benefits. Retiree Medical Benefits are paid on a pay as you go basis by Bay County and the other Component Units. In 2001, Bay County proposed prefunding the Retiree Medical Benefits through a VEBA trust in order to reduce the unfunded liability of Retiree Medical Benefits, reduce the cost of providing such benefits, and increase the security of this retiree benefit. A VEBA plan is a type of tax-exempt trust used by its members and eligible dependents to pay for eligible medical expenses; and

WHEREAS,

In September 2001, the Bay County Board of Commissioners adopted the VEBA Trust which provided that the "trustees of the VEBA (generally being the current trustees of BCERS) are hereby designated as the trustees of the VEBA; and

WHEREAS,

It is the recommendation of the VEBA Board and the Office of Bay County Corporation Counsel that the VEBA Trust be amended so that the VEBA and BCERS Boards have the same trustees and same composition; and

WHEREAS,

Section 5.2 of the VEBA Trust governs and allows for amendments of the VEBA Trust and provides in part,

this Trust Agreement may be amended at any time or from time to time and in any manner by resolution of the Bay County Board of Commissioners with the written agreement of the Trustees, and the provisions of any such amendment may be applicable to the Trust Fund as constituted at the time of the amendment as well as to the part of the Trust Fund subsequently acquired, provided that this Trust Agreement shall not be amended in any manner which causes or allows any portion of the Trust Fund allocable to the Plan (or any other plan funded under the VEBA) to be used for the purposes other than providing retiree health care benefits to retired employee of the Employers and their spouses, and dependents (or benefits to such persons under such other plan funded under this VEBA), or in the event of termination of the Plan (or other plan), for purposes other than those described in Sec. 5.1(b) above and permitted by Section 501(c)(9) of the Coase and by 1999 P.A. 149.; Therefore, Be it

WHEREAS, The City of Midland accepted the position and entered into the 2020 Homeland Security Grant Program with the State Police Emergency Management and Homeland Security Division and became the Sub-grantee for the grant. In consideration of the mutual promises, obligations, representations, and assurances in the agreement, the City of Midland is requesting the County of Bay to enter into this 2020 Homeland Security Grant Program Sub-recipient Funding Agreement for the protection of both parties; and

WHEREAS, This Sub-recipient Funding agreement with the City of Midland will cover the FY20 HSGP grant for Bay County in the amount of \$18,099.96. All expenditures are approved by the Fiduciary and the State of Michigan and are fully reimbursed incurring no costs to Bay County; Therefore, Be It

RESOLVED That the Bay County Board of Commissioners approves the 2020 Homeland Securit Grant Program Sub-recipient Funding Agreement with the City of Midland and authorizes the Chairman of the Board to execute said Agreement on behalf of Bay County following Corporation Counsel review and approval; Be It Further RESOLVED That related budget adjustments, if required, are approved.
