### BAY COUNTY PROPOSAL

#### Community Center Outdoor Public Pool Area Millage

Shall the limitation of the amount of property taxes which may be assessed each year against all taxable real and personal property in Bay County be increased by not more than .35 of a mill (35 cents per \$1,000 of taxable value) for a period of 20 years, 2024 to 2043, inclusive, for the purpose of constructing, equipping, furnishing, maintaining and operating a new outdoor Community Center pool area for public use which may include, but is not limited to, a multi-purpose pool that may be used for education, recreation and competition, a splash pad, locker rooms, lounging and deck areas?

This is a new millage that will raise an estimated \$1,238,813 in the first year of the levy.

#### Mosquito Control Millage Renewal

Shall the limitation of the amount of property taxes which may be assessed each year against all taxable real and personal property in Bay County be increased by not more than .55 of a mill (55 cents per \$1,000 of taxable value) for a period of 8 years, 2024 to 2031, inclusive, to continue control and abatement of mosquitos, raising an estimated \$1,946,707 in the first year the millage is levied?

The following is for informational purposes only:

This is a renewal of the .55 of a mill approved by the voters in 2016 that expired in 2023 for the continuation of mosquito control and abatement.

### Bay Metropolitan Transportation Authority Millage Renewal

Shall the limitation of the amount of property taxes which may be levied each year against property in the County of Bay be increased by 1 mill (\$1.00 per \$1,000 of taxable value) on the taxable valuation of real and personal property situated in the County of Bay for a period of five (5) years, 2026 through 2030, inclusive, (this is a renewal of the 1 mill, reduced to .9969 mills by the required millage rollbacks, previously approved by voters that expires in 2025), the said millage to be used exclusively for the continued operation of the Bay Metropolitan Transportation Authority? If approved and levied, the estimated revenue during the first year of the millage would be \$3,587,038.

### **KAWKAWLIN TOWNSHIP PROPOSAL**

#### Fire Protection Personnel Expenses Millage Renewal

Shall Kawkawlin Township impose a renewal millage in an amount not to exceed 1.0 mil (\$1.00 on each \$1,000.00 of taxable value) in the total tax rate limitation on all real and personal property within the Township and levy it for a period of six years, 2024 through 2029 inclusive, for all fire protection personnel expenses which will raise an estimated \$179,721.00 in the first year the Millage is levied?

Should this be adopted?

### **LINWOOD METRO WATER DISTRICT PROPOSAL**

#### Linwood Metro Water District Proposal A

It is proposed that Section 6, Article 3 of the Charter, be amended to list qualifications to be elected as a commissioner similar to all other elected positions in the State of Michigan.

Section 6, Article 3 currently states that you must be twenty-four (24) years of age and be a resident of the district for 2 (two) or more years and be a taxpayer, before you are eligible to be elected as a commissioner. If amended, Section 6, Article 3 will read as follows:

Section 6, Article 3. Qualification of Commissioners. An individual is eligible for election as a commissioner to the Linwood Metropolitan Water District Board if the individual is a citizen of the United States and is a qualified and registered elector within the metropolitan district when the individual seeks to be elected by the filing deadline.

Shall this amendment as proposed be adopted?

#### Linwood Metro Water District Proposal B

It is proposed that Section 6, Article 4 of the Charter be amended in recognition of changes to the state law dealing with and governing Michigan Metropolitan Districts to state that all elections occur in November, the Commission wishes to preserve the staggered terms of the five (5) Commissioners.

If amended, Section 6, Article 4 will read as follows: Article 4. Term of Office.

(a) The regular term of office of members of the commission shall be four (4) years.

(b) Beginning with the November 5, 2024, election, two (2) commissioners are scheduled for election on November 5, 2024, to their four (4) year term and three (3) commissioners are scheduled for the election to their four (4) year term in November of 2026, to preserve the benefit of staggered terms that has existed since the inception of this district.

(c) The term of office of each commissioner shall commence at twelve o'clock noon on the 1st day of January following such elections.

Shall this amendment as proposed be adopted?

#### Linwood Metro Water District Proposal C

In recognition of the changes by the Michigan Legislature it is proposed that Section 6, Article 6, be amended to indicate that the first regular meeting following the November election shall be in the month of January instead of August, and at that meeting, the board's officers shall be elected by the Board of Commissioners from among its members.

If amended, Section 6, Article 6, will read as follows: Article 6. Commission Officers.

(a) The Commission shall conduct its first regular meeting following the election (in November), in the month of January, at which time the Board of Commissioners shall elect by written ballot the following officers, President, Vice-President, Secretary, Treasurer.

Shall this amendment as proposed be adopted?

### Linwood Metro Water District Proposal D

The original Charter provided for compensation for the Commissioners in the sum of Two Dollars (\$2.00) for each meeting actually attended, not to exceed Twenty-Five Dollars (\$25.00). In recognition of the inflation from 1954 to current, it is proposed that Section 6, Article 8, will read as follows:

Article 8. Compensation of the Commission.

Each member of the District Commission shall receive as compensation for his/her official service the sum of Six Hundred Sixty Dollars (\$660.00) per year.

Shall this amendment as proposed be adopted?

### Linwood Metro Water District Proposal E

In recognition that inflation has continued to erode the compensation paid to commissioners, it is proposed that a new Article 11 be inserted in Section 6, Article 11 as follows:

Article 11

Compensation for District Commissioners shall be adjusted by December 1st in every even year by utilizing the increase, if any, in the Consumer Price Index, for the two (2) years prior to that date. The Consumers Price Index will be utilized as published by the United States Department of Labor and any increase in compensation shall take effect on January 1, when the new Commissioners take office. The adjustment may only occur before a commissioner takes office and may not increase his/her compensation while in office.

Shall this amendment as proposed be adopted?

### Linwood Metro Water District Proposal F

Section 7, Articles 2-8, discuss numerous vehicles and petitions to become nominated and run for the office of Linwood Metropolitan Water District Commissioner on the Board of Commissioners. In lieu of these regulations, and in recognition of the legislature's change to the Metropolitan District Act, it is proposed that the Articles 2 through 8, inclusive, be deleted and replaced with Article 2.

Article 2. Elections — All elections in the Linwood Metropolitan Water District shall be administered and conducted under the provisions of the Michigan Election Law Public Act 116 of 1954, MCL 168.1 et seq., as amended.

Shall this amendment as proposed be adopted?

## **BANGOR-MONITOR METRO WATER DISTRICT PROPOSAL**

### Bangor-Monitor Metropolitan District Charter Amendment

This proposed Amendment to the Charter is being suggested to provide cost of living increases to the District Commission members compensation without the need to submit ballot proposals to the District Electors on a repetitive and regular basis.

It is proposed that Section 6 of the Bangor-Monitor Metropolitan District Charter be amended by adding Article 11 as follows:

Article 11. Cost of living increases for district commission members. Compensation for district commission members shall be adjusted by December 31' for every even year by the Consumer Price Index, published by the United States Department of Labor.

Shall this Amendment as proposed be adopted?
