

With dwindling financial assistance and resources, the Health Department continues to effectively serve this community without jeopardizing the health and safety of its populace, a top priority of the current administration. Efforts to secure grant funding for existing and new programs are always at the forefront. This is both commendable and praiseworthy. The 2015 Bay County Department of Community Health Annual Report reflects the success achieved through their efforts.



Message from the Health Officer

To the Bay County Executive, Board of Commissioners and Citizens of Bay County:

On behalf of the management and staff of the Bay County Health Department (BCHD), I am very pleased to present the 2015 Annual Report. The Annual Report provides an overall picture of the quality programs and services the Health Department delivers to the citizens of Bay County. For over seventy years, the staff of the Bay County Health Department has worked diligently to protect you from health threats, to educate you and your neighbors regarding health issues, and to provide healthy solutions in order to advance our community's health. Many of the activities performed by this Department occur behind the scenes, with the primary focus of preventing diseases or conditions that cause disease, disability, or injury. Because of this, many people do not recognize the important role public health plays in their daily lives.

2015 presented the Health Department with a number of challenges and opportunities. First and foremost, during this year, the number of accidental overdoses and deaths due to opiates in Bay County reached alarming proportions. Accordingly, a public health advisory was issued in June and the Health Department led the way by convening the Bay County Heroin Task Force to coordinate between law enforcement and treatment agencies, develop opportunities for treatment, and educate the public.

In 2015, the Bay County Health Department was able to provide a diabetes prevention program through community partnerships. As a result of a grant received by the Michigan Health Information Alliance (MiHIA), BCHD was able to train staff as lifestyle coaches to facilitate the CDC Recognized Diabetes Prevention Program. This program is a yearlong program with the overall goal for participants to effectively manage body weight and increase physical activity. BCHD was able to provide programs reaching out to the community and one in collaboration with Dow Corning Employees.

The partnership with Saginaw Valley State University continues with the expansion of the University Clinic. The University Clinic is a product of a grant to SVSU from the Health Resources Services Administration (HRSA) of the United States Department of Health and Human Services. The clinic meets the medical needs of medically underserved families and individuals in our community, particularly those who suffer from multiple chronic conditions and do not have access to a regular medical provider. We are happy to report that the clinic's operations are expanding with a new and innovative partnership with Bay Arenac Behavioral Health to integrate mental health care into clinic services.

BCHD continues to collaborate to assess the health and well-being of the community with its many partners including McLaren Bay Region, the Bay Health Plan, the Bay Area Community Foundation, the United Way of Bay County, and Bay Arenac Behavioral Health Authority. The second round of the Bay County Community Health Assessment, in which data was collected from secondary sources, was completed in 2015. A phone survey completed in mid-2016 indicates that while issues such as chronic diseases and problems with access to care still abound, the number of adults without health insurance has dropped to 5%, one of the lowest rates in the State of Michigan. BCHD will continue to work to develop a Community Health Improvement Plan to provide a roadmap to better health for all of Bay County residents. In sum, these efforts will help us effectively develop and provide services that truly meet the needs of Bay County residents.

The mission of BCHD is to protect and promote a healthy community and safe environment by providing quality services through all stages of life. We hope this report provides insight to the dedicated and tireless work of the staff and partners of Bay County Health Department, in fulfilling this mission. Household Hazardous Waste

Household Hazardous Waste Collection Program:

The Household Hazardous Waste Collection Program gives Bay County residents a legal and cost-free way to dispose of unwanted household chemicals that cannot be disposed of in the regular trash. The program is sponsored by the Dow Chemical Foundation and Bay County Health Department. A variety of items are accepted during collection, such as automotive products, cleaning products, garden and lawn products, paint products, and personal and health care products.

Health Education

Community Health Assessment

Bay County Health Department, in collaboration with McLaren Bay Region, Bay Arenac Community Mental Health, Bay Health Plan, and Health Delivery Inc., has completed another 3 year Community Health Assessment (CHA). The CHA consists of the collection of hard data, which includes morbidity and mortality, maternal and child health, and population information. Information is obtained from sources including the US Census, Michigan Department of Health and Human Services Vital Statistics, and County Health Rankings. In addition to the hard data, a phone survey has been conducted among Bay County Residents. The results of the Community Health Assessment can be found on the Bay County Health Departments webpage at www.baycounty-mi.gov/health.

Eat Safe Fish Program

The Goal of the Health Education Division is to improve the health of individuals and the community through presentations, community events, and providing educational materials on health related topics. Through the Eat Safe Fish and Wild Game program, Health Educators participated in numerous outreach events and provided education and presentations to organizations and events in the Tri-County area.

Diabetes Prevention Program

The Bay County Health Department is partnering with the <u>Michigan Health Improvement Alliance (MiHIA)</u> to provide the Diabetes Prevention Program (DPP) for Bay County residents. This is a <u>FREE</u> program for adults in Bay County who have pre-diabetes and are at risk of developing diabetes.

The DPP is a year-long program, which consists of 16-weekly core sessions followed by 6-monthly post-core sessions. Participants are taught strategies for incorporating physical activity into daily life and eating healthy. Sessions meet for 1 hour. Two Health Educators have been training as Lifestyle coaches to facilitate the program, and one Health Educator has been trained as a Master Trainer. As a Master Trainer she will be able to train other lifestyle coaches in the area to facilitate the program. Three programs are currently being facilitated with a total of 12 out of 36 people reaching the goal of 5-7% weight loss.

Childhood Lead Education and Screening

The BCHD continues to screen all children for Elevated Blood Lead Level (EBLL) through the WIC program at 12 and 30 months old. In addition, the BCHD Laboratory receives referrals and completes testing for lead screenings. Currently in Bay County there are 9 children with an EBLL, 4 received case management services by the Public Health Nurse.

Hearing and Vision Program



The Family Planning Clinic serves men and women of childbearing age for reproductive health needs. Clients may utilize the clinic for the following types of services: pregnancy testing and referral, sexually transmitted disease testing and treatment, and contraceptive needs. Women desiring a physical exam may obtain a breast exam, pelvic exam, Pap smear, and appropriate lab work.

Health Screening and Testing

The Health Screening Program provides testing, diagnosis and treatment of sexually transmitted diseases, thereby helping to promote and protect the health of the community. Chlamydia, gonorrhea, syphilis, Human Immunodeficiency Virus, and Hepatitis B and C can be tested for through this clinic. Positive results are counseled, treated or referred for treatment and a process of partner notification is initiated.

The Immunization Clinic puts considerable time and effort to ensure that children in Bay County are vaccinated according to schedules developed by the Centers for Disease Control and Prevention (CDC). Laboratory Services

The Bay County Health Department's Laboratory Services provides a variety of diagnostic and analytical services to support public health initiatives related to the citizens of Bay County. These services include: testing for sexually transmitted diseases, cholesterol screening, lipid profiles, glucose screening, lead testing, and pregnancy testing. The lab also tests well water for fecal coliform, measures bacterial counts of public swimming pool water, and analyzes water from rivers, beaches and streams for suspect contaminations.

Holiday Gift Baskets and Holiday Angel Project

In cooperation with the Bay County Food Network the Division on Aging delivered 60 holiday food boxes to 27 homebound clients. A new program, The Holiday Angel Project, received donations from residents. As a result, 59 bags were distributed to homebound Seniors.

Senior Safe at Home

In collaboration with the Bay City Department of Public Health, the Division on Aging implemented a new program called "Senior Safe at Home." Seniors are able to request from the following 5 options: 1) Residential Safety, 2) Fire Awareness and Safety Review 3) Home Energy Efficiency Review, 4) 911 Emergency Contact Information Review, and 5) CPTED Property Clean Up. Requests are then referred to the appropriate agency for follow up through the Division on Aging Case Management Team.

Retired Senior Volunteer Program (RSVP) with United Way

In collaboration with the Retired Senior Volunteer Program, the Division on Aging was able to distribute 151 meals to the VITA program from February 19, 2015 to April 13, 2015. The Division on Aging was also able to make referrals to the RSVP through the Friendly Caller Program.

Special Events

The Special Events for Seniors and Special Programs for Older Adults enable Bay County seniors to enjoy cultural, educational, and recreational events and to be recognized as valued members of the community.

University Clinic




