

GOALS


The goal of public health administration is to establish and maintain a community focus on public health through the development of an efficiently organized, adequately staffed and effective Health Department.

ENVIRONMENTAL HEALTH DIVISION

The Environmental Division of the Bay County Health Department (BCHD) protects the public's health through programs established by the Michigan Public Health Code and local Sanitary Ordinances. These programs focus on the prevention of disease and exposure to pollutants via education, inspection of facilities and enforcement of the referenced laws. The majority of prevention and abatement of environmental threats are accomplished through education.

The Environmental Health Division of the Health Department consists of six professional environmental health staff. There are five Sanitarians and one Secretary. The Sanitarians are registered by the State of Michigan to provide the services of the Division.

FOOD SERVICE PROGRAM

Food establishments and vending locations, which dispense foods and drinks to the public, are routinely inspected by the Health Department. Sanitarians consult with food service operators and food service personnel on the safe handling and preparation of food. Education of the food service operator on the proper methods of safe food handling is a vital function of the Division. Sanitarians review and approve proposed new and remodeled food service facilities and approve food service licenses. In conjunction with the Michigan Department of Agriculture, Sanitarians work closely with the Health Department's Communicable Disease staff to investigate instances of possible food poisoning.

PRIVATE/SEMI-PUBLIC ON-SITE SEWAGE PROGRAM

On-site sewage disposal permits are issued for homes and businesses which are not served by municipal sewer systems. Sanitarians conduct field evaluations to determine the suitability of conditions for on-site disposal of sewage. The Division reviews construction plans, consults with owners and engineers on proper design and construction of on-site systems. The Division issues permits for the construction of new and replacement sewage system and conducts final inspections to assure that systems are installed according to required rules and regulations.

ENVIRONMENTAL HEALTH DIVISION HIGHLIGHTS AT A GLANCE



In 2008, a total of 172 households participated in the Household Hazardous Waste Collection Program. Approximately 10,339 pounds of material was collected and safely disposed of. The Household Hazardous Waste Collection Program gives Bay County residents a legal and cost-free way to dispose of unwanted household chemicals that cannot be disposed of in the regular trash. The program is sponsored by the Dow Chemical Foundation and Bay County Health Department. A variety of items are accepted during collection, such as automotive products, cleaning products, garden and lawn products, paint products, personal and health care products.

This year marked the beginning of a year-long public education campaign for Bay County's adoption of a Phosphorus Ban Ordinance. This ordinance requires that no phosphorus fertilizers be used on residential properties when soil levels for lawns are adequate.

The Bay County Health Department is expected to continue and receive funding for the Household Hazardous Waste Collection Program in 2009.

SERVSAFE FOOD SERVICE SANITATION PROGRAM

The ServSafe Food Service Sanitation Program is a 16-hour ServSafe Essential course offered to all persons in the Food Service Industry. This course is offered through the Bay County Health Department and taught by Registered Sanitarians Daniel Dicks and Barry Hugo. The program provides training in basic sanitation principles: Food Microbiology, Prevention of Food-borne Illness, Safe Food Handling, Personal Hygiene, Construction and Maintenance of Food Service Facilities, Pest Control, and HACCP Principles.

The Immunization Division provides immunizations to individuals in the community with an emphasis on the pediatric population. The Immunization Division provides:

- * Daily clinics with evening hours twice a month.
- * Seasonal immunizations; flu, pneumococcal, and meningococcal for college students
- * Distribution of vaccine to area providers enrolled in the Vaccines for Children Program (VFC)
- * Annual site visits to VFC providers to assure vaccine safety and contract compliance
- * Michigan Care Improvement Registry (MCIR): Area providers are assisted with entry of vaccines into the MCIR to assure accuracy of immunization records
- * Oversight and monitoring of immunization levels for children and entry of vaccines into the MCIR to assure accuracy of immunization records

* Participation in the Immunization Task Force to bring together key individuals in the community that have a vested interest in assuring children's vaccinations

- * Provider education: A Public Health Nurse provides in-services to area providers to help assure staff is knowledgeable and up-todate on vaccine information.
- * Payment is derived from insurance sources, and accommodations are made for the uninsured, including a sliding fee scale to match resources of individual persons.

FAMILY PLANNING PROGRAM

The Family Planning Clinic serves men and women of childbearing age for reproductive health needs. Clients may utilize the clinic for the following types of services: pregnancy testing and referral, sexually transmitted disease testing and treatment, and contraceptive needs. Women desiring a physical exam may obtain a breast exam, pelvic exam, pap smear, and appropriate lab work. All methods of birth control are available as well as abstinence information and pre-conception education. Fees for service are based on a sliding scale according to the client's income and family size. All services are rendered in a confidential and caring manner.

WOMEN'S, INFANTS AND CHILDREN'S (WIC) PROGRAM

WIC is a federally funded program to prevent malnutrition in high-risk pregnant, breast-feeding, and nonlactating women, infants and children until age 5. The income eligibility is at or below 185% of poverty with verification of income required. The medical and nutritional risk factors are determined by a Registered Nurse, Registered Dietician, or Nutritionist, and support staff is trained to screen for nutritionrelated health problems. WIC coupons purchase over \$1,500,000.00 in food in local grocery stores in the Bay County area. Health Department clients receive WIC services along with other needed services, such as, Immunizations, Maternal and Infant Support Services, Childhood Lead Screening, and voter registration. Families are provided a user-friendly "one stop shopping service". WIC clients are also linked to the Bay County local Farmer's Market through Project Fresh. This is a collaborative program with MSU Extension and Bay County Health Department. WIC families are introduced to the local market and participate in Nutrition Education class, which teach how to prepare meals using local produce.

EMERGENCY PREPAREDNESS & MANAGEMENT DIVISION

The Bay County Health Department Emergency Preparedness & Management Division (EP&MD) had a very busy 2008 due in part to Bay County being the host of a multi-county, regional full-scale exercise. The train derailment exercise took place on September 24, 2008. In addition to local resources, regional, state and federal resources were called upon for assistance. This was the first full-scale exercise of this magnitude for Bay County, as well as the first regional exercise for the fourteen counties that make up Michigan's Emergency Management and Homeland Security 3rd District. The exercise went very well due to the planning and preparation by the various community agencies and first responders.

Other activities this division implemented included particulate and full-face respirator fit-testing provided to eighteen County employees, two Deputy Medical Examiners, and three Animal Control Officers. The EP&MD staff also participated in monthly/quarterly 800 MHz radio drills with the Region 3 Healthcare Preparedness Network and the Michigan Department of Community Health, Office of Public Health Preparedness.

In March, the BCHD held their annual staff in-service training day. The trainings included Bloodborne Pathogens and Norovirus clean-up procedures, as well as a review of several Health Department and County policies/procedures. In addition, staff received training on Emergency Preparedness topics, including: the Strategic National Stockpile (SNS), Public Health Emergency Preparedness and County Emergency Management, Modular Emergency Medical System (MEMS), BCHD Incident Command Center activation and call-down procedures, exercise requirements, and updated training on the All-Hazards Comprehensive Public Health Response Plan and the Continuity of Operations Plan (COOP). In the afternoon, staff participated in a pandemic influenza tabletop exercise, which provided education regarding their role during an influenza pandemic, as well as an overview of the roles other community partners (i.e. hospital and area physicians) will play in a pandemic outbreak.

COMMUNITY OUTREACH/EDUCATION

Several outreach and community collaborations took place during 2008. Staff attended neighboring local health department drills/exercises within Region 3, and participated in health fairs and community events in Bay County. The Community Health Educator provided Pandemic Influenza, Blood-borne Pathogens, Emergency Preparedness, and Hygiene/Hand-washing presentations to staff, community groups, and schools. In addition, the Health Department utilized a fall flu clinic, held in Pinconning, as an opportunity to test the agency's capabilities to dispense medications to the public, should a pandemic influenza occur. In addition, this exercise served as an outreach opportunity to educate residents of the Pinconning area regarding the Health Department's emergency preparedness plans.

Bay 3 TV Programming

Bay County Health Department utilizes Bay County's local access television station Bay 3 TV as an outreach mechanism to inform residents of agency programs, specific services, and events. BAY HEALTH PLAN



The Bay Health Plan is a low cost, community-sponsored program that provides basic healthcare coverage to low-income individuals in Bay County. The plan provides limited coverage for doctor visits, prescriptions, lab tests and X-rays with affordable co-pay amounts. This is not insurance, however, the coverage for many basic healthcare services has assisted many Bay County residents with their healthcare needs. Eligible residents must be between the ages of 19-64 and do not qualify for any other governmental insurance program.

Other communicable disease control efforts include: monitoring disease reporting by physicians and laboratories to detect trends and assess the impact of diseases on the public's health; ensure communication between public health agencies, private physicians and hospital/occupational infection control personnel; advise and educate health care providers regarding public health interventions; and disseminate health education messages to the community and media to enhance disease control efforts.

Physicians, clinical laboratories, primary and secondary schools, childcare centers, and camps are required to report the occurrence or suspected occurrence of any disease, conditions or infection, as identified in the Michigan Communicable Disease Rules. In addition, all other health care providers are authorized to report to local health authorities. Together, they play a key role in state and local efforts to control communicable diseases. The public health system depends upon these reports of diseases to monitor the health of the community and to provide the basis for preventive action.

HEALTH SCREENING SERVICES

The Health Screening Program provides testing, diagnosis and treatment of sexually transmitted diseases, thereby helping to promote and protect the health of the community.

CHILDREN SPECIAL HEALTH CARE SERVICES (CSHCS)

The Children Special Health Care Services Program provides medical specialty care and assistance to eligible children and some adults within Bay County who have chronic physically disabling conditions. In 2007, Plan of Care, Care Coordination and Case Management Services were added.

EARLY AND PERIODIC SCREENING, DIAGNOSTIC AND TREATMENT (EPSDT)/LEAD PROGRAM

The EPSDT/Lead program provides early detection of developmental delays before school age. In conjunction with periodic screening, this nurse tested children for lead, administered immunizations, and made referrals to Early On, MIHP, WIC, and area physicians for children attending lead clinics. For children whose Blood Lead Levels (BLL) were at or above 10 micrograms per deciliter of blood, this nurse referred those children to their physicians for a confirmatory lead test. For those whose confirmatory tests resulted in same or higher, those families were contacted with follow-up lead information. For those children whose BLL exceeded 20 micrograms per deciliter, a home visit was made with a nurse and the Elevated Blood Lead (EBL) Investigator/Risk Assessor.

The EPSDT / Lead Program began in October, 2006, and is 100% funded through PIE grant funds administered through the Bay City Public Schools.






